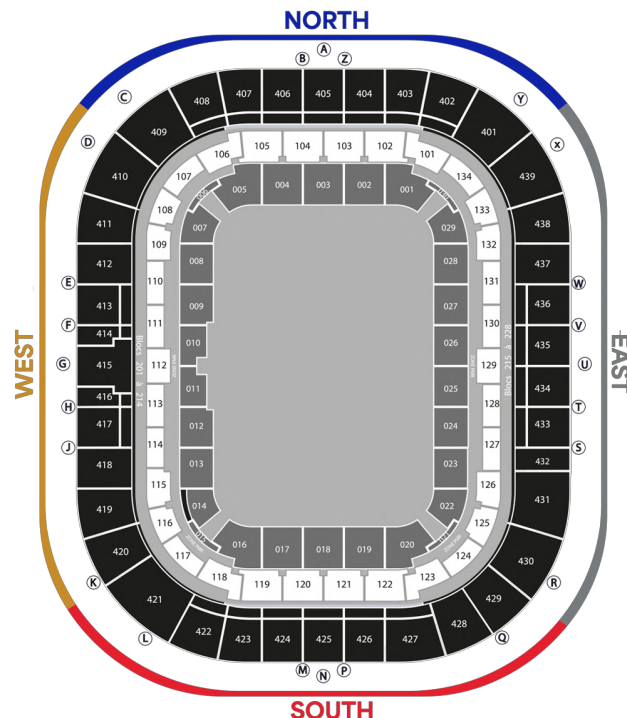

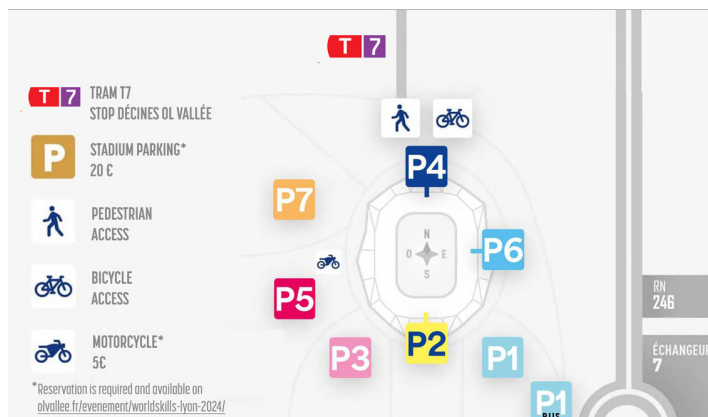

### GENERAL TERMS OF USE

- The purpose of these GTCU is to define the rights and obligations of WSL2024 and the Customer in the context of registration for the Event, with the aim that the acquisition of Tickets will grant access to the Event. Accordingly, any holder of a ticket to attend WorldSkills Lyon 2024 Event undertakes to comply with certain conditions set out below. The customer acknowledges that they have read and understood these GTCU prior to validating their reservation.
- Tickets cannot be returned or exchanged. In the event of loss, theft or destruction, tickets will not be replaced or refunded. No duplicates will be issued. All exits from the premises are final.
- All persons, including children and people with reduced mobility, must be in possession of an individual ticket to gain access to the stadium. Access to the stadium implies tacit acceptance of the stadium's internal regulations, which are available from the operator.
- Any use of a ticket and any admission to the stadium are subject to the present GTCU and to the General Terms and Conditions of Sale, as well as any applicable regulations or decisions of the organization issued by the relevant authorities. WSL2024 reserves the right to cancel a ticket, refuse admission, or expel a person from the premises if they act in breach of these GTCU.
- Any member of the public may be searched and/or subject to a pat-down upon entering the stadium. Any person refusing to comply with security and control measures will be refused entry to the stadium without being entitled to any reimbursement.
- Members of the public are informed that, to ensure their safety, the premises may be equipped with a video surveillance system, under the control of judicial police officers, and the footage may be used for legal purposes.
- Any ticket holder who broadcasts or reproduces sounds, images, descriptions or results via the Internet or any other means is subject to the WorldSkills Lyon 2024 Media Code of Conduct, which can be viewed on the website under: "Media - Press Information". Any infringement of rights, including intellectual property rights, may result in legal action and/or claims for damages.
- Any ticket holder present at the stadium will be deemed to have given their irrevocable consent to the use by WorldSkills Lyon 2024, free of charge, for the entire world without time limitation, of their voice, image and representation by video recording or live broadcast, retransmission or recording, photography or any other medium existing at present or in the future, taken or recorded on the occasion of the event.
- Any ticket holder is forbidden to bring into the stadium any documents, leaflets, badges, insignia, signs, symbols or banners of any size, of a political, ideological, philosophical advertising nature, or anything that could be used for commercial purposes that could be seen by third parties, any object likely to be used as projectiles, to constitute a weapon, as well as pyrotechnic items and alcoholic beverages. Anyone in possession of such items will be expelled from the stadium and may be subject to legal action.
